- There are 4 printed pages in this form. Please ensure you have downloaded all pages.
- SC Judgement:** The Hon'ble Supreme Court of India has held in the case of Society for Unaided Private Schools of Rajasthan v/s U.O.I and Others Writ Petition @ No. 95 of 2010 that the provisions of the Right of Children to Free and Compulsory Education, Act 2009 (RTE) shall not apply to **Unaided Minority Educational Institutions**. The National Commission for Minority Educational Institutions, Government of India, New Delhi has **declared this to be a Minority Educational Institution within the meaning of Section 2 (g) of the NCMEI Act.**
- The School being a Minority Institution reserves its Constitutional right to give preference to children from the Sikh community. Preference will also be given to siblings, wards of alumni (who studied for a minimum period of 5 years), Management and wards of Staff.
- There is **no screening** of the children or their parents.
- The **presence of both parents** with the child is mandatory on the day of admission. If parents are divorced or if a parent is widowed or single, **necessary legal documentation** must be presented at the time of admission. *Please refer to point 8.*
- Two passport-size **photographs** must be attached with the admission form in addition to the one pasted on this form. The **child's name and date** (when picture is taken) should be printed below the Image (*as per sample shown*). In addition, one postcard-size photograph of the family is to be pasted on page 4 of this admission form. All photographs should not be more than one month old.
- At the time of submission of this form:
 - A sum of **Rs. 150/-** is to be deposited at the time of registration.
 - Originals of all documents (mentioned on page 2)** are to be brought for verification and a notarized true copy of the **original birth certificate** must be submitted along with this completed form.
 - In case, on verification or any subsequent point of time a document is found to be fabricated, forged or tampered with, the admission would automatically stand cancelled with immediate effect. Any fee paid (admission or tuition) will not be refunded.
- If it is determined that critical information has been withheld, either intentionally or inadvertently, the School reserves the right to either withdraw a student's acceptance or terminate the student's placement in class. Contradictions and discrepancies detected will result in the cancellation of admission without any notice.
- The ward's and parents' names must be written on this form as on the birth certificate. The name of the child as mentioned in these submitted legal documents will be entered into school records and further provided to the Ministry of Education. **No changes will be made thereafter in the date of birth or names.**
- Notarized or self-attested photocopies of the child's, father's and mother's **aadhaar cards** may be attached with this completed admission form. However, the child's aadhaar card is not mandatory.
- Incomplete forms / those filed with incorrect information / unattested documents or forms not accompanied with the required documents, will **NOT** be considered for admission purposes. Admission will be withheld until all requisite documents are submitted.
- Forms and all the accompanying documents/photographs, once submitted, will become the property of the school and will not be returned. In case of loss or damage of documents, copies of documents submitted in school will not be supplied without a written application.
- Contact numbers/e-mail ids given must be permanent, valid and working. In the event that the school is unable to reach the parent at the given number(s)/e-mail id, the school will not be responsible for the consequences.
- The final list of selected candidates will be put up on the notice board.
- The school does not provide **transport facilities**. There are a few private operators plying buses, who may be contacted.
- Necessary **safety and security measures** are implemented in the school. Policies and procedures to be followed in case of eventuality are clearly written in the Child Protection Plan (CPP). Parents can ask about these and apply only after their queries have been answered.
- Admission to the school means a complete acceptance and observance of the rules and regulations laid down by the School Management.
- The school follows a zero tolerance policy against violence, any kind of substance abuse and indecent / immoral conduct. A child, if found indulging in any of the above activities, will be expelled with immediate effect.
- For classes K.G. and above, submission of a **transfer certificate with PEN number** issued by the Principal of the school last attended is mandatory along with an attested photocopy of the **original marks sheet / report card** duly signed by the Principal of the previous school.
- One month's notice** is mandatory prior to the withdrawal of a student from school. Otherwise, the fee for that month becomes payable. The Transfer Certificate will be issued only after all school dues are cleared.
- Admission will remain **provisional** until all of the above mentioned **documents have been submitted** in the school office. Admission will be **regularized** only after the submission of the requisite documents.
